S.E.2d at 435 (citation omitted). In this case, we find that the defendant's interest in the property has been compromised by the agency for service of process and by the notice of sale. Without the plaintiff's notices, the defendant would have had absolutely no opportunity to protect its interest in the property. The plaintiffs' repeated attempts to serve the defendant have made it impossible for the defendant to protect its interest. "It is recognized that immediate and irreparable injury will result when a party to a contract may, through their negligence, unknowingly waive their rights to protect themselves against subsequent events which would prevent them from enjoying the fruits of their contract." Id. at 145, 446 S.E.2d at 435 (citation omitted). We find that the defendant's interest in the property has been adequately compromised to support an injunction. "Additionally, when a

mortgagee is served with a notice of sale... the mortgagee has the right to intervene in the foreclosure proceeding under Code § 45-21." Eason v. Eason, 166 Ga.App. 517, 520(3), 305 S.E.2d 437 (1983). Here, the defendant properly sought to intervene in the proceedings.
