Appellant was charged with the murder of the husband and wife, but the jury also convicted him of the attempted murder, claiming that the husband's testimony could not be used to show the elements of that crime. (Ibid.) The court determined that appellant's reliance on People v. Miller (1891) 91 Cal. 293 was misplaced. It held that the testimony of a surviving spouse cannot be a witness to the facts of the homicide. There can be no doubt that a surviving spouse is competent to testify to the killing of his or her deceased spouse." (Minjarez, supra, 24 Cal.App.4th at p. 94.) It further held: "The rule of Miller v. People is inapplicable, as the defendant has not been charged with the murders of the three homeschooling mothers. They charged him only with causing the death of their children.
